2022 Ballot Measures



This year, millions of voters who turn out for the midterm elections will have a chance to vote on ballot measures on a number of key issues. Here are some of the ballot measures to watch through Election Day:

REPRODUCTIVE RIGHTS



Michigan Reproductive Freedom for All

The Fairness Project is supporting the Reproductive Freedom for All campaign in Michigan to pass a citizen-initiated ballot measure, Proposal 3, that would enshrine reproductive rights in Michigan's constitution, including the right to have an abortion. Volunteers collected more than 750,000 signatures, a statewide record, in order to qualify the measure for the ballot.

Vermont for Reproductive Liberty



The Fairness Project is partnering with the Vermont Reproductive Liberty campaign to pass a legislatively referred ballot measure, Proposal 5, that will codify reproductive freedom in Vermont's constitution, including the right to seek an abortion or use contraception.

Other measures

California voters will decide on whether to add a constitutional amendment ensuring the right to have an abortion and to use contraceptives. **Montanans** will decide whether to grant personhood rights to fetuses born at any stage of development. In **Kentucky**, voters will see a proposal similar to the one defeated in **Kansas** earlier this year, which would amend the state constitution to state that there is no right to have an abortion.

HEALTH CARE



South Dakotans Decide Healthcare

South Dakota is one of only 12 states that still has not expanded Medicaid under the Affordable Care Act. The Fairness Project has worked to pass Medicaid expansion in six states so far and is now working with a broad coalition of local partners in South Dakota including doctors, teachers, and farmers to support the South Dakotans Decide Healthcare campaign. If passed, Amendment D would expand Medicaid to about 42,000 South Dakotans.

Other measures

This year, **Oregon** voters will decide whether to amend their state constitution to guarantee every resident access to affordable health care as a fundamental right.

ECONOMIC JUSTICE



Raise the Wage Nebraska

The Fairness Project is working with Raise the Wage Nebraska to pass a ballot measure, Initiative 433, that will increase the minimum wage statewide from its current level of \$9/hour to \$15/hour by 2026, adjusting for inflation each subsequent year. This would immediately impact approximately 150,000 workers, or nearly a fifth of Nebraska's workforce.

Healthcare Rising Arizona



The Fairness Project is supporting Healthcare Rising Arizona to pass its ballot measure, Prop 209, that would limit exploitative practices by medical debt collectors. If passed, the measure will shield more of people's assets, including homes and vehicles, from repossession, and would cap the interest rate on medical debt at 3% and limit wage garnishment for medical debt to a maximum of 10% of earnings.

Other measures

Massachusetts will decide whether to create a 4% state income tax on income over \$1 million on top of the existing 5% income tax, with the revenue going toward education and transportation. **Illinoisans** will vote on guaranteeing the right to collectively bargain for state employees.

POLICE ACCOUNTABILITY



Yes on A, Los Angeles County

In Los Angeles County, the Fairness Project is working with the Yes on A campaign to pass a county-wide ballot measure that will allow the Los Angeles County Board of Supervisors to impeach the county's sheriff for cause.

CANNABIS

Voters in **Arkansas**, **North Dakota**, and **South Dakota** will see citizen-initiated ballot measures this year that would legalize possession and use of cannabis. In **Missouri**, court challenges delayed a ballot measure to legalize cannabis statewide, but a ruling by the state Supreme Court allowed the measure to appear on the ballot in November. Voters in **Maryland** will also vote on a legislatively referred measure that would decriminalize possession of small amounts of cannabis.

VOTING AND DEMOCRACY



Arizona

The Fairness Project is working with stakeholders in Arizona to execute "No" campaigns on three anti-democratic proposals. Prop 128 would allow the state legislature to amend or repeal voter-approved ballot measures if any portion has been declared unconstitutional or illegal by the Arizona Supreme Court or U.S. Supreme Court. Prop 129 would limit citizen-initiated ballot measures to a single subject. Prop 132 would require a 60% vote rather than a simple majority for voters to pass certain ballot measures.

Arkansas



The Fairness Project is also working with stakeholders in Arkansas to defeat Arkansas Issue 2, which would require a 60% supermajority vote to adopt constitutional amendments and citizen-initiated state statutes. The Fairness Project worked with partners to defeat a similar proposal in South Dakota, Amendment C, earlier this year.

Other measures


Voters in **Connecticut** will see a question on whether to expand early voting, and voters in **Arizona**, **Nebraska**, and **Ohio** will see questions on stricter voter ID requirements. Thanks to the Promote the Vote coalition in **Michigan**, voters will have a chance to decide whether to expand early and absentee voting, access to dropboxes, and more. **Nevadans** will vote this year on whether to implement open top-five primaries and ranked-choice voting.

SLAVERY AND INDENTURED SERVITUDE

Several states this year will have an opportunity to abolish outstanding permissions or exceptions to slavery or forms of indentured servitude. **Alabama** voters will approve or refuse a new state constitution that, among other changes, removes racist language and permissions for involuntary servitude. Voters in **Louisiana**, **Oregon**, **Tennessee** and **Vermont** will also decide on whether to amend their state constitutions to repeal language that allows slavery and involuntary servitude as punishment or as repayment for a debt.
